1 Scope

This document specifies requirements for three types of flexible rubber hose for pressure spraying of agricultural chemicals and/or fertilizer products within a temperature range of -10 °C to $+60\text{ °C}$.

4 Classification

Three types of hose are specified as follows:

- **Type A:** Maximum working pressure of 1,0 MPa (10 bar);
- **Type B:** Maximum working pressure of 4,0 MPa (40 bar);
- **Type C:** Maximum working pressure of 6,0 MPa (60 bar).
