1 The Minister in exercise of the power conferred by Section 20 (5) of the Industrial Research and Standards Act, 1961 (No. 20 of 1961), and the Industrial Development Act, 1993 (No. 19 of 1993) and with the consent of the Minister for Enterprise and Employment, hereby declares as follows:

1 This instrument may be cited as the Standard Specification (Ignitability Requirements of Mattresses Tested with Secondary Ignition Sources Simulating Unknown Behaviours) Declaration, 1988 (Amendment) No. 1 : 1994.

2 Irish Standard 418 : 1988 set out in the Schedule to the Standard Specification (Ignitability Requirements of Mattresses Tested with Secondary Ignition Sources Simulating Unknown Behaviours) Declaration, 1988 is hereby amended as indicated in the Schedule hereto.

Page 7 Clause 4 Principle

Lines 7 and 8. Replace 'I.S. 244 Requirements for smoulder and flame resistant upholstery' with 'EN 1021 Furniture - Assessment of the Ignitability of upholstered furniture' - Part 1: Ignition source: Smouldering Cigarette (ISO 8191-1 : 1987 modified).

Line 11. Replace 'I.S. 244' with 'EN 1021 Furniture - Assessment of the ignitability of upholstered furniture' - Part 2: Ignition source: Match flame equivalent (ISO 8191-2 : 1988 modified).

Page 9 Clause 10 Ignition Sources

Sub-Clause 10.2 Replace 'I.S. 244' with 'EN 1021 Part 1'.

Sub-Clause 10.3 Replace 'I.S. 244' with 'EN 1021 Part 1'.

Sub-Clause 10.4 Replace 'I.S. 244' with 'EN 1021 Part 1'.

Sub-Clause 10.5 Replace 'I.S. 244' with 'EN 1021 Part 2'.

Page 9 Clause 11 Preparation

Sub-Clause 11.2 to become

'Durability of treatment of the outer cover (ticking). If the outer cover (ticking) of the mattress has been flame retardant treated the sample used in the test procedure should be subjected to the Water Soak Procedure in Annex D of EN 1021 Part 2'.

Page 13 Clause 15 Butane Flame Test

Sub-Clause 15.1 Replace 'I.S. 244' with 'EN 1021 Part 2'.
