NSAI in exercise of the power conferred by section 16 (5) of the National Standards Authority of Ireland Act, 1996 (No. 28 of 1996) and with the consent of the Minister for Enterprise, Trade and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Identification of cores in cables and flexible cords) Declaration, 2002.
2. (1) The Specification set forth in the schedule to this declaration is hereby declared to be the standard specification for Identification of cores in cables and flexible cords. The Schedule comprises the text of HD 308 S2:2001.
(2) The said standard specification may be cited as Irish Standard HD 308 S2:2002 or as I.S. HD 308 S2:2002.
